## Living Collection Assistant – Amphibians Grade: 5

Directorate: Operations

Location: WWT Slimbridge Wetland Centre

Reporting to: Living Collection Supervisor- Ectotherms

Main function of post: To assist with the day to day husbandry of the animals on sections.

Supervisory responsibilities: Volunteers, Work Experience students

## Main duties of the post

- To assist with the detailed management of animals within the Ectotherm section.
- Monitor and provide a balanced and appropriate diet for animals, including food preparation, stock management and care of livefood.
- Carry out behaviour observations.
- Assist with breeding and population management of animals in line with the collection and breeding plans.
- Maintain exhibits to a high standard by carrying out enclosure maintenance, ensuring life support systems are running correctly and water/substrate changes are done when needed.
- To deliver engaging and educational talks, sufficiently presenting and interacting with animals in front of visitors to highlight our key wetland messages.
- To ensure that the health of the living collection is of the highest standard, in collaboration with the veterinary team, including health monitoring individuals and assisting with medications.
- To assist in the maintenance of both written and ZIMS records, census, and monitoring and recording behaviour and welfare.
- To ensure scrupulous hygiene standards and biosecurity are practised and maintained in all areas.

- To be responsible for working within the WWT health and safety policy and guidelines ensuring that the health, safety and wellbeing of yourself and others is an integral part of how you work.
- To assist with maintain high standards of welfares and enrichment in the Living Collection, including carrying out welfare observations and assessments.
- To assist and carry out research relating to the Living Collection.
- To assist with general duties in other sections of the wider living collections team where required.
- To work alongside volunteers encouraging, developing and supporting them in their work for WWT, ensuring that they have a positive volunteering experience.
- To be responsible for engaging with the WWT Sustainability Statement, being aware of negative environmental impacts and incorporating sustainable ways of working within your role.
- To interact with our visitors and supporters in a positive way, shaping unforgettable experiences and helping them understand and connect to wetlands.

In addition to the duties and responsibilities listed, the post holder is required to perform any other reasonable duties that may be assigned by the supervisor shown above, when the need arises.
